WHAT IS THE SUBCLASS 188 - INNOVATION STREAM

The subclass 188 visa is a temporary visa that allows individuals to operate a new or existing business in Australia. It is the first stream under the Business Innovation and Investment (BIIP) category and is colloquially referred to as the 188A.

In a nutshell, the visa applicant must achieve a score of at least 65 on the points test, have a successful business with a certain annual turnover and have a specified amount in total net business and personal assets. Once you meet these requirements, you are eligible to apply.

Now what?

When you have this visa, you will be expected to carry out business and investment in Australia and after a specific period, you will be able to apply for the Permanent Subclass 888 under the Innovation Stream.

At MND Co, we often have clients come to us and ask us how they should go about setting up their business and investments. Common questions are, which industry should I start a business in, do I need an accountant, what is the tax rate, what are the workplace laws, what business structure should I use?

- have owned and managed a business for at least 2 years prior to applying for the subclass 888
- . Had direct and continuous management role in that business
- . Submitted Business Activity Statements to the Australian Tax Office
- . Have an ABN
- . Had a turnover of AUD 300,000 (depending on the State or territory)
- . Meet the assets and employee requirement
- . Meet the residence requirement
